Surface Joint Venture v. DuPont – January 2003. Court: United States District Court, Western District of Texas, Austin (testified on antitrust [claim dropped by plaintiff] then on \$47 million damage claim [plaintiff settled for \$0 during the trial])

VIA vs Intel – April, 2003. Court: United States District Court, Western District of Texas, Austin (testified on patent infringement damages; case settled before trial)

George Lehockey, et al v. Tidel Technologies – Nov, 2003, US District Court, Southern District of TX, Houston Division (securities case; Courtroom Testimony for 2 days, in a Securities Class Certification Hearing before Judge Harvey Brown).

John Wilkinson, et al v. Navigant Consulting – December, 2003, US District Court, Northern District of Texas, Dallas Division (present value of lost future income, incorporating industry effects, professional status, age, labor force participation rates and retirement age)

SourceNet v. Hewlett-Packard – Nov, 2003. Court: District Court of Harris County, Texas, 152nd Judicial District (testimony for HP in a breach of contract case).

CenterPoint Energy Houston, Reliant Energy and Texas Genco – July, 2004, True-Up Hearing, Testified Before the three Commissioners, Texas Public Utility Commission (securities valuation for the defendant Texas Genco re their \$2.4 billion in Stranded Costs)

Intergraph v. Hewlett-Packard – November, 2004. Court: Federal Court, Eastern District of Texas, Marshall Division (testimony on reasonable royalties in a \$1.1 billion patent infringement case).

Sovereign Software v. Amazon.com – June, 2005. Court: Federal Court, Eastern District of Texas, Tyler Division, Judge Leonard E. Davis (testimony on reasonable royalties in a \$150 million patent infringement case).

Klein Becker and Basic Research v. Bodyworx – November 21, 2005. At trial before Judge Sparks, Federal District Court in Austin, Texas (testified on antitrust injury and damages).

Tetco v. Exxon and ExxonMobil – March 6, 2006. At trial before Judge John J. Specia, District Court of Bexar County, 73rd Judicial District, San Antonio. Deposition December 23, 2005 (testimony on contract damages in a \$160 million case).

KCI vs Blue Sky/Medela - May 3, 2006. Patent infringement case in Houston. Deposition only.

Constellation New Energy's Appeal of an ERCOT Decision. January 19, 2007, testified for Constellation before the three members of the Texas Public Utility Commission in a \$125 million electric utility case; deposition January 12, 2007; Constellation was granted its request.
